

**Pure Entertainment Company SS Land Yacht Party Bus**

***Guest Waiver***

I, the undersigned, acknowledge I am a Guest on this Pure Entertainment Company SS Land Yacht Party Bus (Party Bus). Therefore, by my signature I agree to be bound by these Rules of the Road listed below and understand that violation of any of these Rules may result in my eviction from this vehicle, and that determination will be made solely by the Driver. Specifically, I acknowledge and agree to the following:

- BE NICE! Driver has the right to eject any individual(s) whom they deem to be disruptive, intoxicated, argumentative or who pose a safety issue to themselves or to others. So NO fighting!
- Sit down while the bus is moving. Move about at your own risk. Please use caution on steps.
- No glass, firearms, or weapons on the Party Bus.
- No SMOKING at any time (this includes e-cigarettes and vaping)
- No Drugs or illegal activity.
- If you are under 21 you may NOT drink. Driver has the right to inspect ID's and containers of passengers who appear underage. If we think you are drinking, we can check and kick you off the vehicle.
- Do not remove alcohol from the bus. No open containers can come on or off the bus at any time.
- Have fun but be reasonable. Alcohol impairs motor skills, balance, and judgement. If you are overly intoxicated you may be denied entry from the vehicle.
- If you drink make sure you have a safe ride home.
- Please do not cause any damage to the bus and please do not stand on the seats. The client agrees to assume full responsibility for any damages to the interior or exterior of the bus.
- Throwing up or other accidents will incur a cleaning fee of \$150.
- Do not leave items on the bus. Pure Entertainment Company is not responsible for any lost, stolen, or damaged articles during the ride or articles left after the ride has ended.
- We aren't liable! By signing up for and participating in the ride, I (and my spouse, family, heirs, etc.) hereby irrevocably covenant, promise and agree to indemnify and hold harmless Party Bus, its officers, employees, agents, contractors and representatives, heirs and assigns ("Indemnified Parties") from and against any and all losses, claims, expenses, suits, costs, demands, damages, negligence, or liability, joint or several, of whatever kind or nature which the Indemnified Parties may sustain (including injury and death) or which they may become subject arising out of or relating in any way to your booking and/or the services provided by but not limited to all our bus owners & their companies, including without limitation in each case attorneys' fees, and expenses actually incurred in defending against or enforcing any such loss, claims, expenses, suits, costs, demands, damages, negligence, injuries, or liabilities.
- All provisions of this contract will be interpreted under the laws of the State of Missouri. Any controversy or claim arising out of or relating to this contract or any breach of this contract (or of the decision to arbitrate) shall be settled by binding arbitration pursuant to the Commercial Arbitration Rules of US Arbitration and Mediation and will be held in St. Louis County, Missouri.
